Instruction Manual

Inserting batteries

Insert the two AAA batteries with + and - sign as indicated inside the battery compartment. The clock will start running from 12:00 AM January 1, 1996.

To Set Calendar

Slide the **SET SWITCH** to **CALENDAR**. Press **MONTH**, **DATE**, or **YEAR** buttons to set the month, date, and year of the calendar. Then slide the **SET SWITCH** to **LOCK** to run the clock and calendar in normal mode.

To Set Time

Slide the **SET SWITCH** to **CLOCK**. Press the **HR** or **MIN** button to set the current time. Then slide the **SET SWITCH** to **LOCK** to run the clock and calendar in normal mode.

12 HR AM/PM or 24 HR International Time Format

Press the **12/24** button to choose the desired time format.

°C or °F Temperature Format

Press the **°C/°F** button to choose the desired temperature format.

SYNCHRONIZING WITH WWV

To synchronize the time with WWV, follow the instructions for “To Set Time”. Set the time to one minute before the designated time. Then press the **MIN** button at the signal. The seconds will automatically reset to zero each time the minutes are changed. Now your clock is synchronized with WWV.

This clock is designed to hang on a wall. For best LCD contrast, hang the clock on the wall so that the viewing angle is less than 70° as shown above.
